



Admission to Secondary School: September 2023

If you live in Reading (paying Council Tax to Reading Borough Council) and have a child moving into Year 7 of state secondary school in September 2023, you must apply to Reading School Admissions. If you live in another local authority, you must apply through your home authority.

Brighter Futures for Children is responsible for the delivery of children's services, including school admissions, on behalf of Reading Borough Council.

Please read our guide "Admissions to Secondary School 2023/2024 – Guide for Parents and Carers" before you apply. The guide is packed with information and advice about how your application is processed and considered by the relevant admissions authorities.

Please read this form carefully, completing all sections marked "*" and submit all required documents to ensure your application is processed correctly. Failure to do so may result in your child's application being delayed or considered incorrectly.

Please write the names of up to four preferred for your child to attend in the sections below and give your reasons. Although your preferences will be considered equally, the order of your preferences is important; the school you would most like your child to attend should be listed as Preference 1 followed by Preferences 2, 3 and 4. You must list all your preferred state schools including Grammar schools, Academies, Free Schools and schools in other Local Authorities. You do not need to complete any other Local Authority application form. You are advised to list more than one school but cannot list more than four schools until after National Offer Day.

The admission criteria for each of the schools in Reading are set out in the "Admissions to Secondary School 2023/2024 – Guide for Parents and Carers". The admission criteria for schools in other Local Authority areas can be obtained from relevant Local Authority.

Please consider the following:

- Applications are not considered on a first come, first served basis. All applications received on or by the 31
 October 2022 will be considered equally. Late applications may be accepted as "on time" (where there is good
 reason for the late submission) until 31 December 2022. Supporting evidence of reason must be submitted with
 the late application. Applications received after 31 December will be processed after National Offer Day.
- Your preferred schools are considered equally according to each school's published admissions criteria. No priority is given to your preference ranking. Your ranking is considered only where it is possible to offer more than one of your preferences; in such cases the highest possible preference is offered.
- How does a school allocate places where it received more applications than it has places available? Admission policies for your preferred schools may differ. We would encourage you to consider naming your designated area (DA) school as one of your preferences. Places are not reserved at DA schools for those living in the area. If you do not name your DA school, your child will not be considered for admission. If you do not obtain a place at one of your preferred schools, you may find that your DA school is full and is no longer an option for your child. Please note that living in the DA of a school does not guarantee admission to that school. Further information about DA's can be found in the guide. If you are unsure which is the DA school for your home address, please contact the Admissions Team
- Listing one preference only does not increase the likelihood of obtaining a place at that school

Supplementary forms – you may need to complete additional forms for the following schools:

- Blessed Hugh Faringdon Catholic School has admissions criteria based on religion. Form to be returned to the school
- Maiden Erlegh School in Reading consider applicants who are eligible for pupil premium in a higher admissions category. Form to be returned to Reading School Admissions
- Reading Girls' School has selection tests for admission to their selective stream and a form is needed to register for the tests. Form to be returned to the school
- **John Madejski Academy** test for aptitude in sport and have a form to register for the tests. **Form to be returned to the school**
- Reading School and Kendrick School entrance test registration forms should be sent to the schools by June deadline. Test results will be made available to you before the closing date for returning your local authority application form. This will help you to decide whether to include the grammar school as a preference.

Medical or social reasons, this category only applies to certain schools; please check whether it applies to your preferred school and what evidence you should supply. The School Admissions Team **will not** contact you for this information and failure to supply supporting evidence may mean your application is not considered for these reasons. Evidence submitted later may not be considered. If you have questions about this admissions category, please contact the Admissions Team.

Siblings: If your child has a sibling attending your preferred school, please tick the box and include his/her name and date of birth. Most schools only consider a sibling who will be attending the school in Years 7-11 from September 2023 (siblings in Years 12 or 13) may not be accepted under this category. Please check the definition of a sibling in the admission policy of your preferred school.

If you are selecting one of the Maiden Erlegh Trust schools (Maiden Erlegh School, Maiden Erlegh School in Reading or Maiden Erlegh Chiltern Edge), please ensure you list the correct one. If you list only "Maiden Erlegh School", we will assume you mean Maiden Erlegh School (in Wokingham).
